

## RULES OF THE BONUS DRAWING CONTEST

The content of these Rules is brought to the attention of the Participants by placing the text in free public access on the Internet at [https://zenex-coin.com/uploads/bonuses\\_rules\\_en.pdf](https://zenex-coin.com/uploads/bonuses_rules_en.pdf). Each person interested in participation in the contest has an opportunity to get acquainted with these Rules before participating. The purchase of ZNX tokens by the Participant through his own account on the affiliate Internet platform <https://bitexpro.eu/> in the minimum amount specified in these Rules means that the Participant has read and agreed to these Rules.

### 1. General Terms.

#### 1.1 Terms and definitions:

**The Drawing contest Organizer (hereinafter referred to as the "Organizer")** is Zeno Club B.V., a company registered under the laws of Curaçao under registration number 154987, registered address E-Commerce Park Vredenberg, Curaçao.

**Drawing contest** is an event aimed at attracting the attention of the audience to the "ZENEX token" project in order to generate or maintain interest in the project and its promotion on the market, conducted by the Organizer in accordance with these Rules, addressed to individuals,

**Participant** is an individual who has a registered account on the affiliate Internet platform <https://bitexpro.eu/>, purchasing ZENEX tokens (hereinafter - ZNX) through his registered account on the affiliate Internet platform <https://bitexpro.eu/> during the period from **April 05, 2022 to July 04, 2022, inclusive**.

**The Winner** – a participant of the Drawing, recognized by the results of the Drawing as having the right to receive one of the bonuses in accordance with these Rules.

**General participation period - the period from April 05, 2022 until July 04, 2022, inclusive**, during which the person who has a registered account on the affiliate Internet platform [https://bitexpro.eu](https://bitexpro.eu/) has the right to purchase ZNX tokens, thus participating in the Drawing.

**The participation period in a stage of the Drawing** shall mean the period of time between the stages of the Drawing from the beginning of the stage of the Drawing up to the determination of the Winners of the stage of the Drawing.

1.2 These Rules regulate the procedure of organization and conduct of the Bonus Drawing contest.

1.3. Attention! The Drawing of bonuses is not a lottery or other similar event due to the fact that the Drawing:

- has the purpose of promoting the ZENEX Token project;
- In order to participate in the Drawing, it is necessary to purchase a virtual asset (ZNX token), the issue of which is not aimed at granting the right to participate in the Drawing;
- the bonuses provided to the Winners by the Organizer shall be formed by the Organizer's own funds and shall not be formed by the proceeds from the sale of special assets or tickets issued for participation in the Drawing.

### 2. The terms of the Drawing contest

2.1 The draw shall be conducted in several stages with the periodicity of one (1) every fourteen (14) days, provided that the total number of tokens ZNX purchased by the Participants in the current stage is not less than the equivalent of 50 000 USDt. If the amount of ZNX tokens purchased by the Participants of the stage of the Drawing is less than the equivalent of 50 000 USDt, such stage of the Drawing shall be deemed failed, and the lines (records) of the ID list shall be transferred to the ID list of the next following stage of the Drawing. The first stage of the Draw shall take place on April 20, 2022, and the last stage of the Draw shall take place on July 13, 2022.

### 3. Conditions for participation in the Drawing.

3.1 In order to participate in one stage of the Drawing, the Participant shall purchase ZNX tokens in the minimum amount of 25 (Twenty five) ZNX through his own account on the Partner's Internet platform <https://bitexpro.eu/> during the period of participation in the Drawing stage, ZNX tokens can be purchased using the "PURCHASE ZNX" button (payment in USDt) or by making an exchange transaction in the exchange window on the main page of the account on the affiliate Internet platform <https://bitexpro.eu/> (using EUR or USDt).

**Individuals who purchased ZNX tokens by means of an order in the trading terminal on the partner's Internet platform <https://bitexpro.eu/> and on third-party resources will not participate in the Drawing.**

**Starting May 08, 2022, person who purchase ZNX tokens via the partner site <https://gdc.club/> will also be considered Participants of the Drawing.**

3.2. The ID of the Participant, who acquired ZNX during the participation in the stage of the Drawing, shall be entered into the ID list of the Participants of the stage of the Drawing (hereinafter - the ID list). In addition to the Participant's ID on the affiliate Internet platform <https://bitexpro.eu/>, the date of the acquisition of ZNX tokens shall also be indicated in the ID list.

3.3. The Participant, who has purchased 25 ZNX tokens, receives one line (record) in the ID list. The right to participate in the Drawing is granted to the Participants who have at least one line (entry) in the ID list. The more minimum numbers of ZNX are purchased by the Participant, the more rows (records) in the ID-list he gets.

3.4. The ID-list is formed by the Organizer and published on the Internet platform <https://zenex-coin.com>. The ID-list is updated with a periodicity of once in 24 hours. Each stage of the Draw shall be held between the Participants of the same formed ID-list. At the same time, the Participant ID, which is an impersonal combination of numbers that does not contain other identifying features of the Participant, and the date of purchase of tokens are not personal data of the Participant within the meaning of the GDPR Directive "On Protection of Personal Data" or other provisions of law. Publication of the ID Sheet on the Internet platform <https://zenex-coin.com> does not constitute disclosure of Participants' personal data.

3.5. The Participant's ID shall be included in the ID list of the next stage of the Drawing, if the Participant purchased ZNX tokens no later than 48 (Forty-eight) hours before the next stage of the Drawing. The last stage of the Drawing to be held on July 13, 2022 is an exception. In order for the Participant's ID to be included in the ID list of the last stage of the Drawing, the Participant must purchase ZNX tokens no later than July 04, 2022.

3.6. Lines (records) of one ID list take part in one nearest stage of the Drawing, the IDs of the Participants of one ID list are not transferred to the ID list of the next stage of the Drawing. In order to participate in the next stage of the Drawing, the Participants shall purchase ZNX tokens for the formation of lines (records) in the ID list no later than 48 (Forty eight) hours before the next stage of the Drawing (the exception is specified in clause 3.5 of these Rules).

3.7. If less than 100 (one hundred) lines (records) are formed in one ID-list of the nearest stage of the Drawing, such stage of the Drawing is considered a failure, and the lines (records) of such ID-list are transferred to the ID-list of the next nearest stage of the Drawing. An exception is the performance of the last stage of the Draw, in case it is a failure, the lines (records) of such ID-list are not transferred to the other ID-list.

3.8. If the Participant is not the Winner of the previous stage of the Drawing, he is entitled to participate in the next stage of the Drawing, and the Participant is provided with the following conditions: when purchasing ZNX tokens in the current stage of the Drawing, the Participant receives lines (records) in the ID-list of the current stage of the Drawing in the amount, determined in the order, established by clause 3.3 of these Rules, as well as in the ID-list of the current stage of the Drawing the lines (records) of the Participant are transferred from the ID-list of the previous stage of the Drawing in the amount equal to the number of lines (records) in the ID-list, which the Participant received through the purchase of ZNX tokens in the current stage of the Drawing.

#### **4. Procedure for determining the Winners of each stage of the Drawing.**

4.1 The Winners of each stage of the Drawing, who are entitled to receive one of the bonuses, and the determination of which bonus is due to the Winner, shall be determined live on the ZOOM Conference by randomly selecting the Participant ID from the stage ID list of the Drawing. Winners are determined by means of a randomizer, eliminating any bias or interest on the part of the Organizer. Winners' IDs are announced at the ZOOM conference where the Winners of the Draw stage are determined.

4.2 At one stage of the Draw the Winner may receive only one of the bonuses. From the moment when the Participant is recognized as the Winner of the stage of the Drawing, he is entitled to one bonus, and the remaining lines (records) of the Participant, recognized as the Winner, are deleted from the ID-list of the stage of the Drawing.

#### **5. Bonuses at each stage of the Drawing.**

5.1 The bonuses are distributed at each stage of the Drawing, the bonuses include:

- One bonus of 500 € + 500 ZNX;
- Two bonuses of €100 + 100 ZNX;
- Five bonuses of 50 € + 50 ZNX.

One Winner is entitled to one bonus.

5.2. Since the bonuses provided to the Winners by the Organizer are formed by the Organizer's own funds and do not depend on the number of ZNX tokens sold and are not tied to the Organizer's proceeds from the sale of ZNX tokens, the amounts of bonuses specified in paragraph 5.1. of these Rules remain fixed for all stages of the Drawing.

## **6. Procedure and terms of receiving bonuses by the Winners.**

6.1 The bonus, which the Winner is entitled to as a result of the stage of the Drawing, shall be credited to the Winner's account on the affiliate Internet platform <https://bitexpro.eu/> within 48 (Forty eight) hours from the end of the ZOOM conference, at which the results of the Drawing stage are determined. At the same time, the crediting of the part of the bonus in the currency € (EUR) is credited only to the fully verified account of the Winner on the affiliate Internet platform <https://bitexpro.eu/>. If the Winner's account on the mentioned Internet platform is not fully verified, the Organizer is deprived of the possibility to credit the bonus in euro (EUR) currency to such an account, which releases the Organizer from any responsibility towards the Winner for not crediting the bonus within the established term.

6.2 The period of withdrawal of the bonus credited by the Organizer to the Winner's account on the Partner's Internet platform <https://bitexpro.eu/> depends on the conditions established on the said Partner's Internet platform, but does not exceed 7 (Seven) banking days.

The bonus withdrawal procedure depends on the terms and conditions set forth on the said affiliate Internet platform. Bonus withdrawal is not possible to all payment accounts (when linking a bank card or an account to an account on the Internet platform <https://bitexpro.eu/> there may be restrictions on banking institutions and payment operators, depending on their geographical location or other criteria). In case of problems with the withdrawal of the bonus to a bank account or an account with a payment operator, the withdrawal of the bonus may be carried out in the digital asset USDt to the crypto wallet of the Winner.

6.3 The Organizer is not a tax agent in relation to the Winner. The winner independently pays all taxes stipulated by the current legislation of the state of his registration when receiving the bonus.

## **7. Rights, duties and responsibilities of the Organizer.**

7.1 The Organizer is obliged:

7.1.1. Inform third parties and Participants about the Rules of the Drawing, about the changes in these Rules, as well as about other information that may affect participation in the Drawing. Informing is carried out by publishing these Rules in the current version on the website [https://zenexcoin.com/uploads/bonuses\\_rules\\_en.pdf](https://zenexcoin.com/uploads/bonuses_rules_en.pdf) or by publishing information in the telegram channel [https://t.me/zenexcoin\\_en](https://t.me/zenexcoin_en).

The publication of changes in the Rules for participation in the Drawing or the publication of the current Rules for conducting the Drawing shall be carried out not later than 2 (two) days before the entry into force of the changes.

7.2 The Organizer has the right:

7.2.1. To cancel each stage of the Drawing before its start, by posting information about the cancellation in the telegram channel [https://t.me/zenexcoin\\_en](https://t.me/zenexcoin_en).

7.2.2. Early termination of the Drawing after its start provided that the Participants are notified of such termination in the order provided by these Rules.

7.2.3 Amends to these Rules is subject to notification of the Participants in accordance with the procedure provided by these Rules.

7.3. the Organizer shall not be liable for failure to fulfill or improper fulfillment of its obligations, as well as for any direct or indirect losses of the Participant associated with participation in the Drawing, resulting from equipment and data transmission network failures, unfair actions of third parties, as well as unforeseen force majeure circumstances, which the Organizer cannot influence and which prevents the fulfillment of the Organizer obligations under these Rules (including, but not limited to, prohibiting the Participant from participating in the Drawing).

## **8. Final provisions**

8.1 The decisions of the Organizer on all issues related to the Drawing, and brought to the attention of the Participants in accordance with these Rules and Regulations shall be considered final and shall apply to all Participants.

8.3. All disputes concerning the Drawing shall be regulated in accordance with the current legislation of the state of incorporation of the Organizer. All claims in relation to the Drawing, participation in the Drawing, crediting of bonuses and fulfillment of obligations by the Organizer, the Participants may present exclusively to the Organizer.
